## **KNOW BEFORE YOU GO!**

### **PARKING AND ARRIVAL TO THE VENUE**

**JAMES L KNIGHT CENTER | 400 SE 2ND AVE, MIAMI, FL 33131**

#### **METRORAIL & METROMOVER**

Take the Metrorail (\$2) to the Government Center station. Proceed to the Metro Mover (FREE), Inner Loop, for the most direct route.

Take the Omni line or Brickell and get off at Knight Center. Down escalators take you to the Tower lobby. Turn right off the escalator and proceed to the Knight Center/Hyatt Regency via the air-conditioned, covered walkway.

#### **DRIVING DIRECTIONS**

- Directions from North and South of Miami: Take I-95 North or South
- Continue on I-95 (N or S) until EXIT 2-A (Biscayne Blvd.)
- At the end of the exit ramp, there is a traffic light.
- At the traffic light, make a right-hand turn onto South East 2nd Ave.
- After making the right-hand turn, make another quick right, and the Hyatt Regency Miami will be on your left, along with the James L Knight Center.

Once on the hotel drive, valet parking will be on your left. For self-parking, bear to the right and take the next right into the Knight Center/ Miami Tower garage. Parking elevators will take you to the Miami Tower lobby that is connected to the Knight Center/Hyatt Hotel by an air-conditioned, covered walkway.

Once you have entered the James L Knight Center, you will be on the second floor of the facility with the Riverfront Hall and Hyatt Lobby. The JLKC Theater, administrative offices, and Miami Conference Center are located on the third and fourth floors of the building.

#### **VALET PARKING**

is owned by the Hyatt Regency Miami and operated by Park One. Please note that we do not validate or offer any discounted rates for valet parking.

#### **SELF PARKING**

is available at the Miami Tower directly across the street. An event rate of \$15- 20 will be charged upon entry. An elevator descends to a covered connector that brings you into the venue. This building is owned by the City and operated by the Miami Parking Authority.

### **PROHIBITED ITEMS**

To ensure the safety of all our guests, the JLKC conducts a search of all persons through a metal detector and bag check system prior to entering the facility. To expedite the process, please see below for prohibited items:

- Bags Larger than 10"x7"x2" only exceptions include:

*Bags with Medical Equipment or Supplies  
Clear Bags up to 12"x6"x12"*

*Diaper Bags: please have items inside gallon plastic bags to expedite the search*

*ALL bags are subject to search. Bags outside the policy may be checked in at our coat room for a fee.*

- Strollers are not allowed upstairs to the theater level; they can be parked in an open area downstairs or checked at the coat room for a fee.

- Balloons

- Umbrellas

- Air Horns/Noise Makers

- Laser Pointers

- Drones

- Professional Cameras with a larger than 7-inch lens

- Guns, Knives, or weapons of any kind

- Signs or Posters

- Animals, exceptions to service animals with paperwork

- Outside Food or Drink

- Glow Sticks

- Clothing or Accessories with Spikes or Sharp Objects

- Any items deemed to be a safety risk by the venue and local law enforcement
